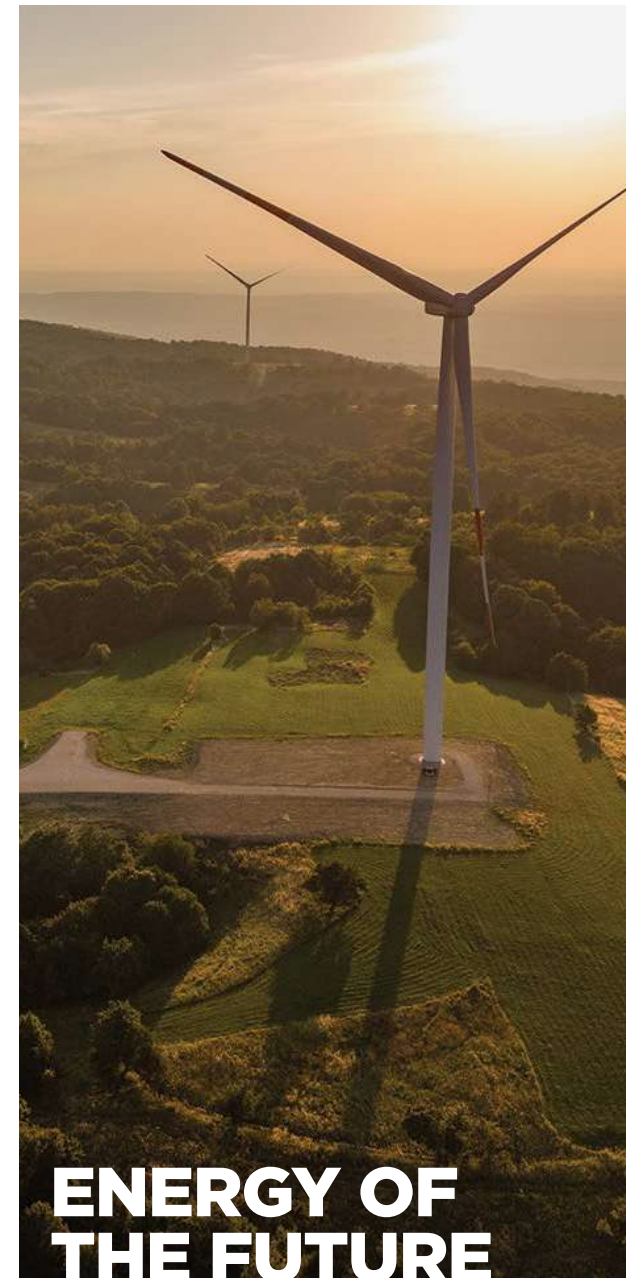

With a tradition longer than 65 years, Carnex is one of the largest producers of meat and meat products in the region, with a complete "farm-to-table" production system.

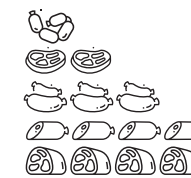
The trademark of the Carnex brand is top product quality, with a combination of traditional recipes and portfolio innovation that follows the trends and wishes of modern consumers.

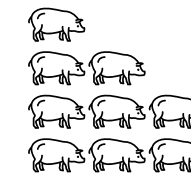

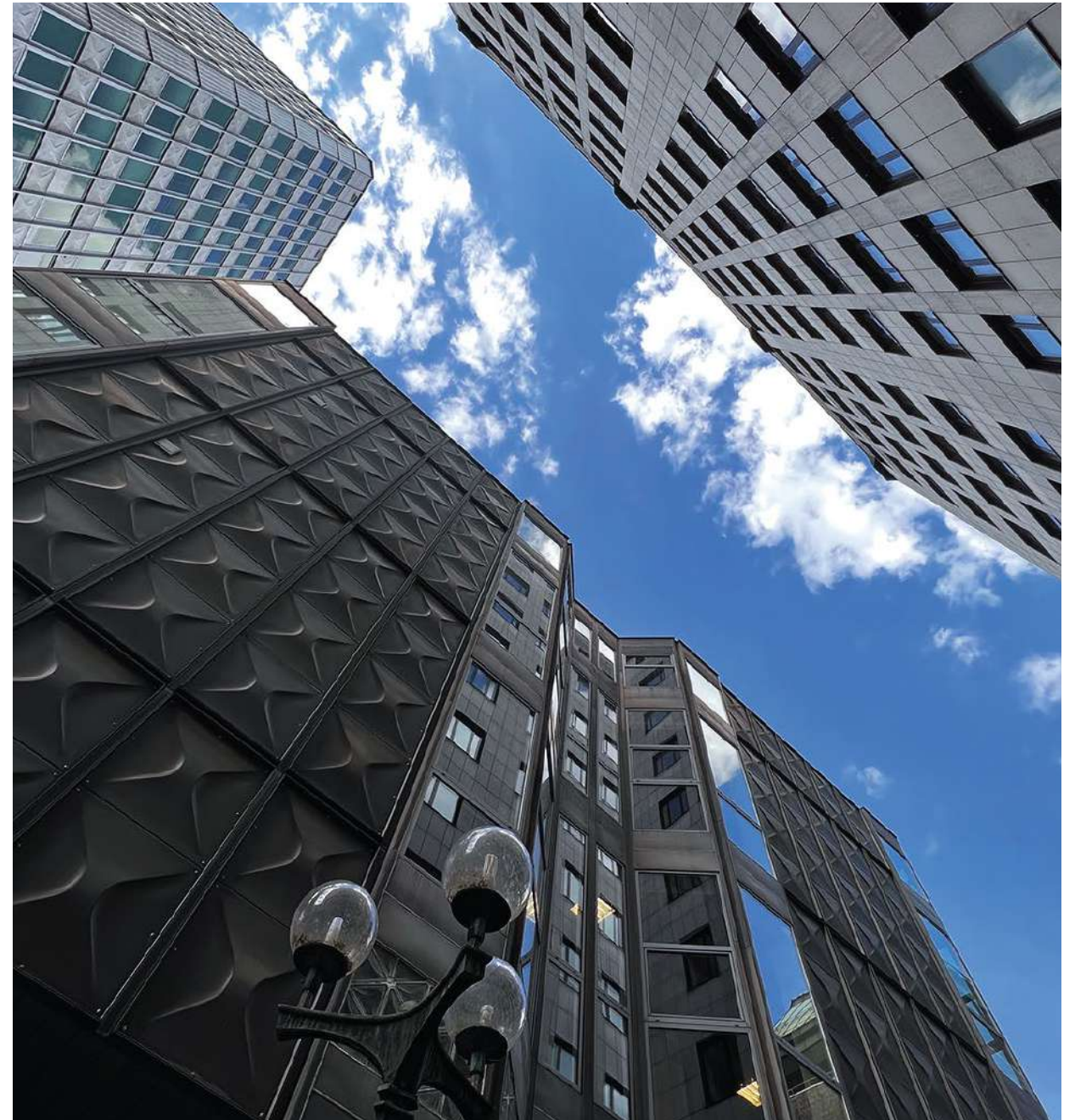
PORTOROŽ AIRPORT

FORUM METALKA

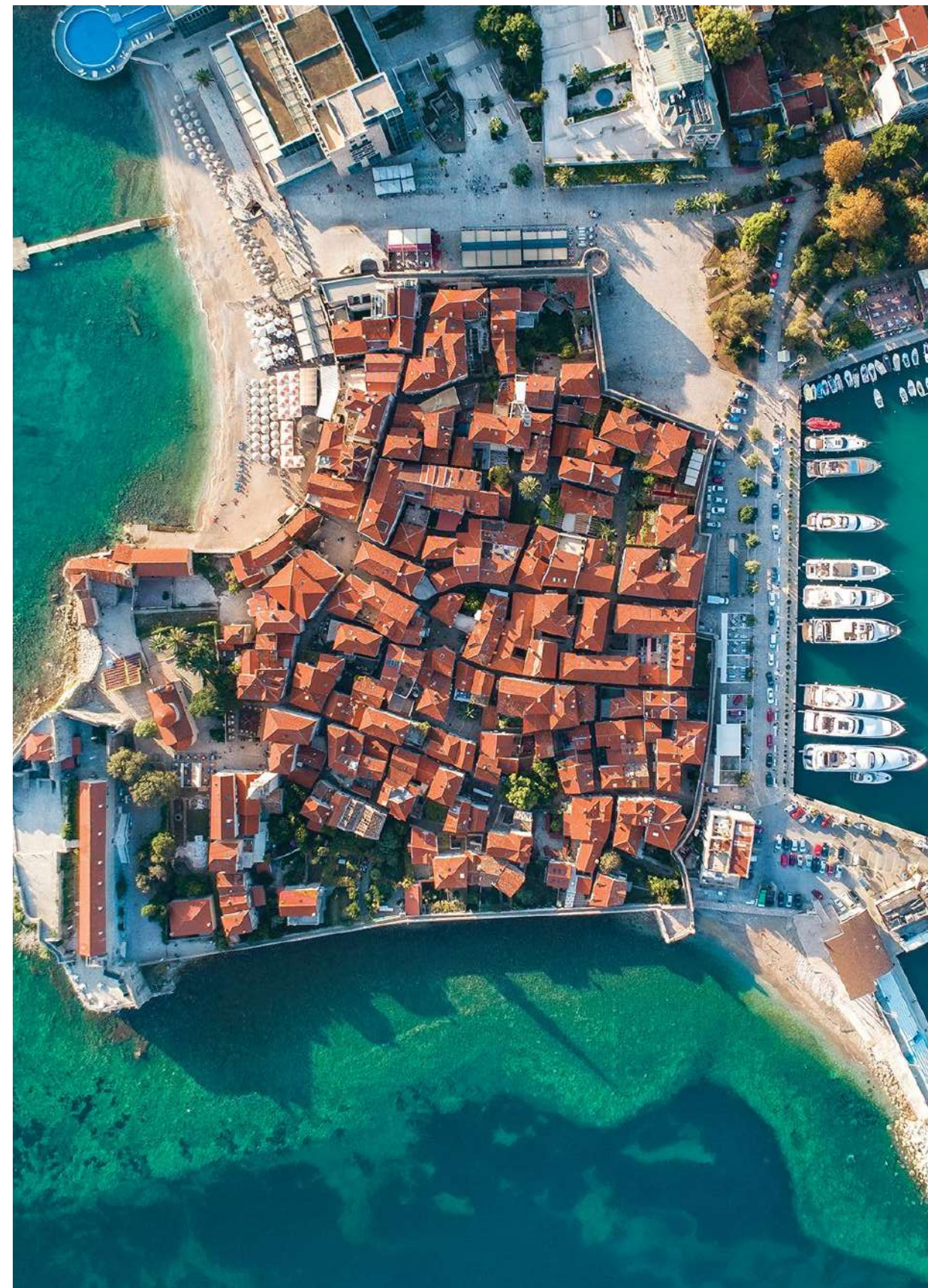

LEADER IN GREEN ENERGY GENERATION IN SERBIA

MK Group is a pioneer in generating electricity from the wind, which opened the first wind farm in Serbia. For almost a decade, we have been one of the most important producers of energy from renewable sources in the Balkans.

Out of four wind farms currently in our portfolio, we built three on the territory of Vojvodina, in partnership with Fintel Energija, while the fourth was built in partnership with the Alfi Renewables investment fund as the first wind farm in East Serbia.

We are continuing with investments in wind, solar, and biomass energy, and the projects we are developing – the completion of which is expected by the end of 2026 – represent investments worth than EUR 900 million.

AGROSOLAR KULA

The first agrisolar project in Adria region, and among the largest in Europe, will cover 770 ha in the territory of Kula in Vojvodina. Along with green energy generation in the solar power plant, the agricultural production of shrub plant species will be possible under the panels. This innovative project is an investment of more than EUR 340 million, and it will be implemented together with Fintel Energija by the end of 2026.

BIOGAS PLANT

The biogas plant in Vrbas operates within Sunoko and uses by-products from the sugar beet processing for green energy generation. The EUR 10 million investment enabled a production capacity of 2.4 MWh. There are plans for investments into new biogas plants within the MK Agri-Food Division.

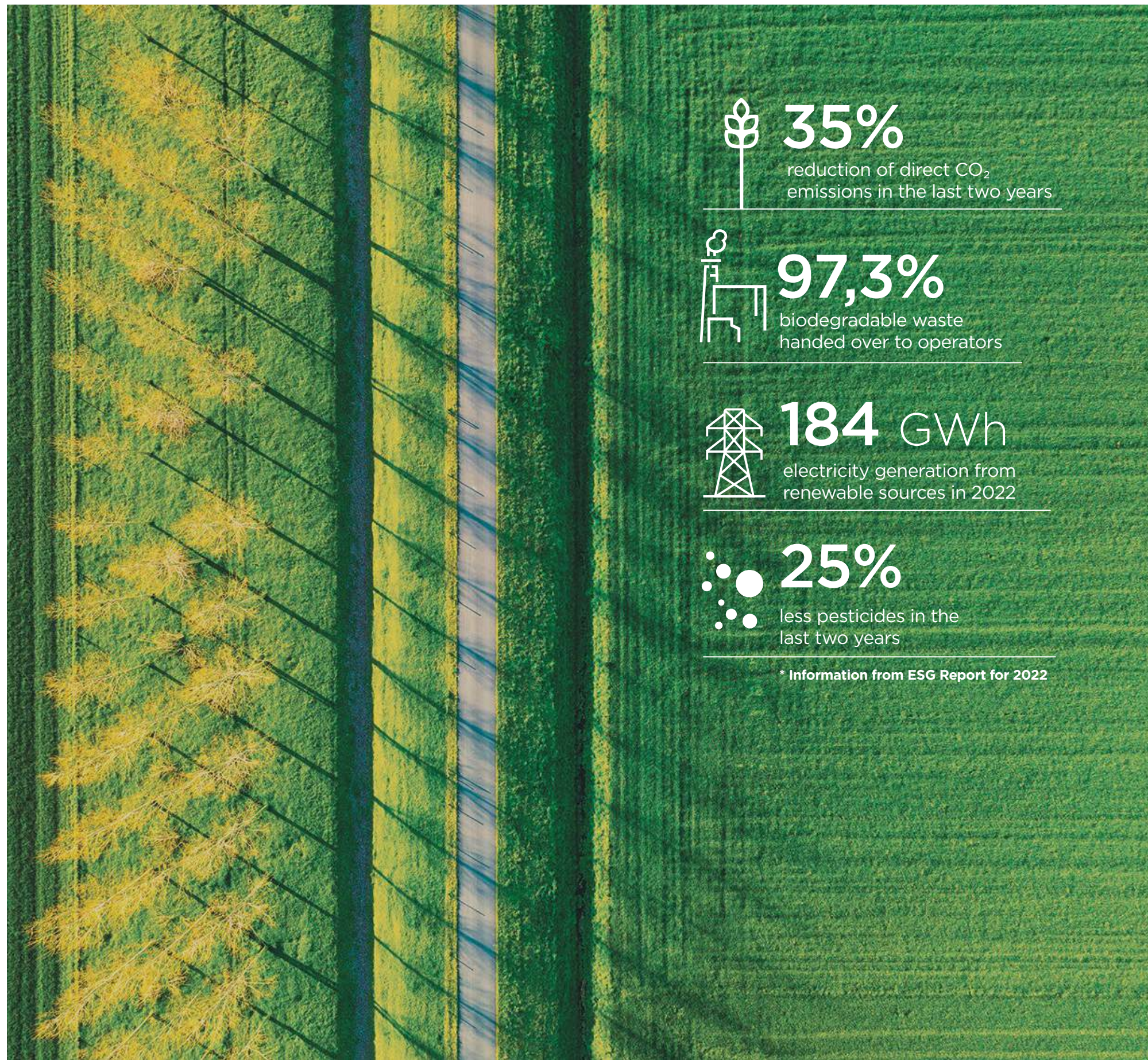
CARING ABOUT THE ENVIRONMENT

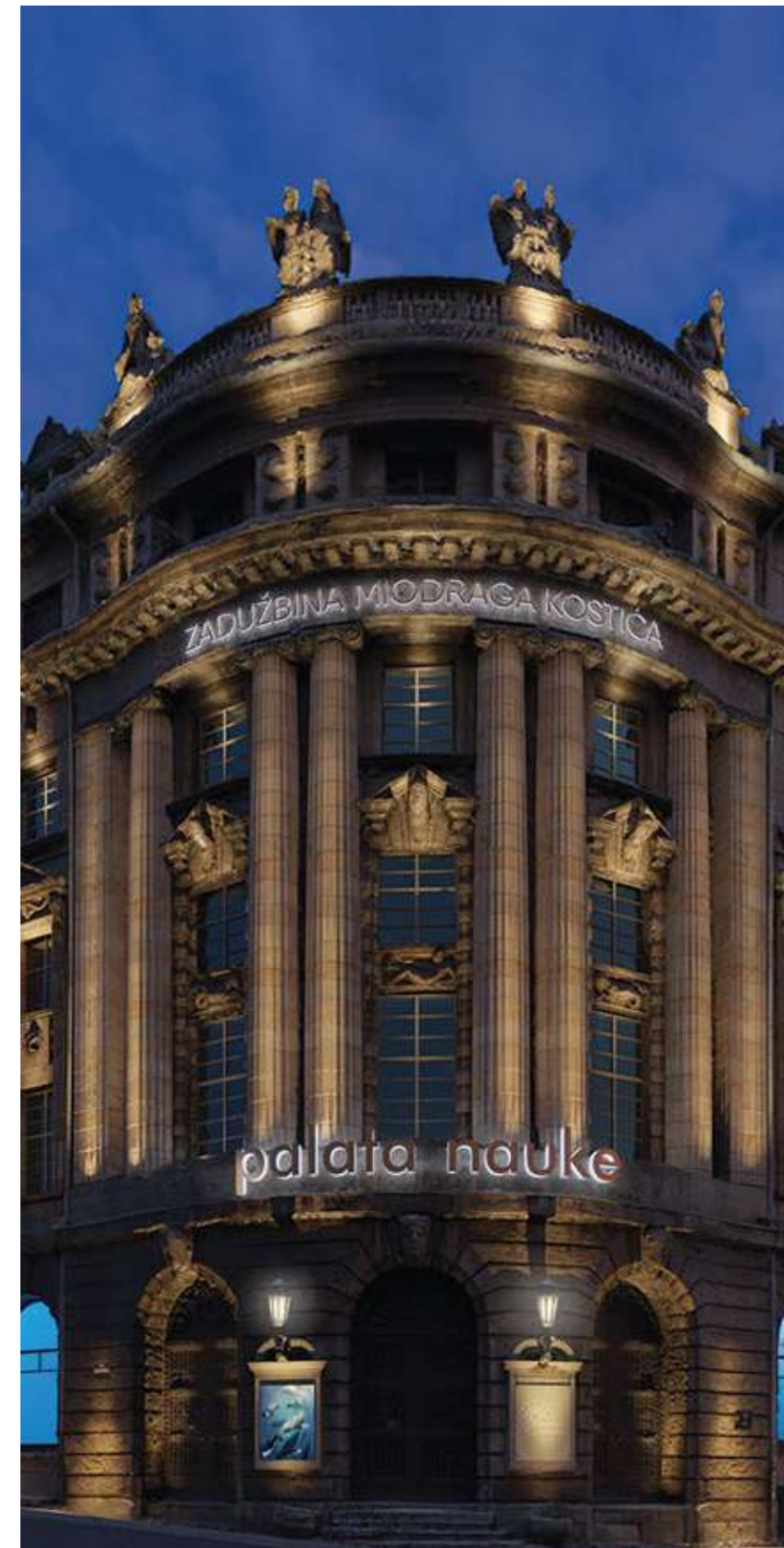

THE MIODRAG KOSTIĆ ENDOWMENT

The Miodrag Kostić Endowment will donate to society the Palace of Science, the first centre for research and the popularisation of science in Serbia and the largest in the region. With more than EUR 25 million for providing support to scientific and technological development, young scientists and education, this is one of the largest individual philanthropy contributions in this region.

With scientific content and activities on more than 5,500 m², scientific work will take place in 19 research centres within this space in partnership with the Faculty of Electrical Engineering at the University of Belgrade. The second part of the space will be dedicated to bringing science closer to the general public, with a focus on nurturing curiosity in children, through a large number of interactive and educational exhibits.
